The above-entitled matter came for a pre-hearing conference on October 22, 2010 pursuant to the Department of Business Regulation's ("Department") Order to Show Cause and Notice of Hearing ("Notice") issued by the Department on September 22, 2010 to Masera Realty, LLC d/b/a The Pines Trailer Park ("Respondent"). The Respondent is a mobile home park that is statutorily required to be licensed by R.I. Gen. Laws § 31-44-1 *et seq.* This matter was continued to allow the Respondent to come into compliance with its licensing requirements with the result being that by the status conference on October 14, 2011, the only outstanding matter was that the Respondent needed to file proof of payment of State taxes. On or about January 24, 2012, the Respondent filed with the Department a letter of good standing from the Division of Taxation indicating that as of January 23, 2012, the Respondent is in good standing with the Division in regards to payment of taxes.

Pursuant to R.I. Gen. Laws § 31-44-1.7, the Department issues annual licenses for mobile and manufactured homes. The Department represents that the Respondent is now in compliance with all statutory licensing requirements set forth in R.I. Gen. Laws § 31-44-1 *et*

seq. and the regulations promulgated thereto for the year 2012 except that it must pay the 2012 license renewal fee and submit a complete 2012 renewal application.¹

Therefore, the undersigned recommends that this matter be dismissed and a 2012 license be issued by the Department for the Respondent <u>upon</u> payment by the Respondent of the 2012 license renewal fee and submission of a complete 2012 renewal application.
