**FINAL CONSENT ORDER**

The Department of Business Regulation (“Department”) and Kenneth R. Norigian (“Respondent”) hereby agree to the following:

1. Respondent is licensed as a Certified Constable (License No. 6091) by the Department in accordance with R.I. Gen. Laws §§ 9-5-10.1 to -10.6.
2. Respondent’s Certified Constable License (“License”) was suspended by agreement on October 14, 2016, and was subsequently reinstated by a Consent Order issued on December 1, 2016, for a total suspension of forty-eight (48) days.
3. Thereafter, on January 13, 2017, the Department summarily suspended Respondent’s License by issuing an Emergency Order Summarily Suspending License, Order to Show Cause Why License Should Not Be Revoked Or Otherwise Sanctioned, Appointment of Hearing Officer and Notice of Pre-Hearing Conference (“Emergency Order”), which was later amended on March 1, 2017.
4. On March 9, 2017, the Department issued an Interim Consent Order in which Respondent’s license was reinstated on a conditional basis. See Exhibit A. Respondent’s License was suspended under the Emergency Order for a total of fifty-six (56) days.

5. At this time, Respondent represents that he has complied with the conditions set forth in the Interim Consent Order and he requests that his license be reinstated in full with no further restrictions.

6. Considering Respondent's completion of two prior license suspensions and his substantial compliance with the Interim Consent Order, the Department agrees to reinstate Respondent's License, provided that:

- a. Respondent agrees to wear his Certified Constable license and badge in a visible location at all times while conducting all constable activities and while serving subpoenas.
- b. Respondent acknowledges that he must comply with the requirements set forth in R.I. Gen. Laws § 9-5-10.5 and that failure to do so could result in the suspension or revocation of his License in accordance with R.I. Gen. Laws § 9-5-10.5.
- c. Respondent acknowledges that he may only use his Certified Constable license and badge in the course of his official duties in accordance with R.I. Gen. Laws § 9-5-10.3(a).
- d. Respondent acknowledges that he cannot remove any object from any location where he was assigned to serve process without the express consent of the owner of any such object.


7. The Department and Respondent agree that this Final Consent Order and its terms represent the final determination of this matter.

8. By agreeing to resolve this matter through the execution of this Final Consent Order, Respondent voluntarily waives his right to the hearing process, and voluntarily waives his right to pursue an appeal to the Rhode Island Superior Court under the Rhode Island Administrative Procedures Act, R.I. Gen. Laws § 42-35-1 *et seq.*


9. This Order takes effect upon approval and issuance by the Director of the Department.





INTERIM CONSENT ORDER

The Department of Business Regulation (“Department”) and Kenneth R. Norigian (“Respondent”) hereby agree to the following:


1. Respondent is licensed as a Certified Constable (License No. 6091) by the Department in accordance with R.I. Gen. Laws §§ 9-5-10.1 to -10.6.
2. Respondent’s Certified Constable License (“License”) was suspended by agreement on October 14, 2016. Respondent’s License was reinstated by a Consent Order issued on December 1, 2016. Thereafter, Respondent’s License was the subject of an Emergency Order Summarily Suspending License, Order to Show Cause Why License Should Not Be Revoked Or Otherwise Sanctioned, Appointment of Hearing Officer and Notice of Pre-Hearing Conference (“Emergency Order”) issued on January 13, 2017, as amended on March 1, 2017.
3. At a pre-hearing status conference held on March 1, 2017, Respondent represented that:
  - a. He has paid all outstanding Rhode Island Traffic Tribunal fines.
  - b. He has reinstated his driver’s license.
  - c. The November 30, 2016 misdemeanor charge by the Warwick Police Department for failure to stop for an accident that resulted in damage to a vehicle, case # 31-2016-11605, was dismissed by the Rhode Island District Court on March 1, 2017.

- d. The January 16, 2017 misdemeanor charge by the Johnston Police Department for driving on a suspended license, 3<sup>rd</sup> offense, case # 31-2017-00481, was dismissed by the Rhode Island District Court on February 6, 2017, because Respondent's driver's license had been reinstated.
  - e. As of March 1, 2017, there were no outstanding civil, criminal or traffic court actions against him.
4. As of March 6, 2017, Respondent's License has been suspended for fifty-two (52) days.
5. Considering the above representations and the length of the License suspension thus far, the Department agrees to reinstate Respondent's License on a conditional basis until this matter is resolved to a final conclusion, either as a result of a hearing or by agreement, provided that Respondent satisfies ALL of the following conditions:


- a. Respondent shall submit to the Department a detailed log of every service of process performed during this conditional licensing period. Respondent shall submit this log by email to the designated Department representative on the 1<sup>st</sup> of each month by 11:59 p.m. All service of process and execution of writs, even those served as a disinterested party, must be included in the log. The log must record the name and address of every person/business served, the date and time of the service, and the nature of the service.
- b. Respondent shall only serve notice of evictions and execute evictions under the supervision of a Certified Constable, who has been approved by the Department as someone who would qualify as a training constable under § 9-5-10.1(b)(3) and who does not have a familial or business relationship with Respondent.
- c. Respondent agrees to notify the Department within three (3) business days of being charged with any crime or cited for any traffic offense.
- d. Respondent agrees to attend the next regularly scheduled Constables Board meeting for an executive session discussion with the Board regarding compliance and best practices as a Certified Constable.
- e. Respondent agrees to wear his Certified Constable license and badge at all times while conducting all constable activities, serving subpoenas, and when accompanied by the training constable.
- f. Respondent acknowledges that he cannot remove any object from any location where he was assigned to serve process without the express consent of the owner of any such object.


- g. Respondent acknowledges that he may only use his Certified Constable license and badge in the course of his official duties in accordance with R.I. Gen. Laws § 9-5-10.3(a).
6. If Respondent fails to comply with any term or condition of this Interim Consent Order (“Order”) within any applicable time period set forth herein, Respondent will be in violation hereunder and the Department shall be entitled to immediately take enforcement or other action, including summary suspension, in accordance with applicable law.
7. If during the pendency of this Order, Respondent is charged with a misdemeanor or felony, the Department may immediately suspend his License.
8. Compliance with the terms of this Order does not relieve Respondent of any obligation to comply with other applicable laws or regulations administered by or through the Department or any other governmental agency.
9. This Order takes effect upon approval and issuance by the Director of the Department.
10. **Notice to Court:** In accordance with R.I. Gen. Laws § 9-5-10.5(a)(5), upon issuance, a copy of this Order will be forwarded to the Chief Judge of the Rhode Island District Court.


