ORDER REVOKING LICENSES
UNDER R. I. GEN. LAWS §19-14-13

The Director of the Department of Business Regulation ("Director") enters this Order Revoking Licenses ("Order") under R. I. Gen. Laws §§ 19-14-13 and 42-35-9(d).

1. On or about May 13, 2009, the Division of Banking (Division) issued a Notice of Intention to Revoke License and of Opportunity for a Hearing ("Notice") to Travis Mortgage, LLC (the "Respondent") concerning the failure of Respondent to submit payment for the examination fee or file a response to the Report of Examination for the examination conducted by the Division pursuant to R. I. Gen. Laws §19-14-23, for Respondent's License Number(s) 20021337LL & 20021338LB (the "Licenses").

2. Said notice was sent certified mail.

3. Neither the Respondent, nor Respondent's agent for service have responded to the Notice of Intention to Revoke License and of Opportunity for a Hearing.


4. Respondent had surrendered the Licenses prior to the issuance of the Notice. By failing to respond to the Notice the Surrender status of the Licenses is hereby changed from "Cancelled" to "Revoked".

ACCORDINGLY, IT IS HEREBY ORDERED THAT:

1. License Numbers 20021337LL & 20021338LB issued to Respondent are hereby revoked pursuant to R. I. Gen. Laws § 19-14-13.
2. The Division shall file a bond claim for any statutory amounts due pursuant to R. I. Gen. Laws § 19-14-23.

THIS ORDER CONSTITUTES A FINAL ORDER OF THE DEPARTMENT OF BUSINESS REGULATION PURSUANT TO R.I. GEN. LAWS § 42-35-12. PURSUANT TO R.I. GEN. LAWS § 42-35-15, THIS ORDER MAY BE APPEALED TO THE SUPERIOR COURT SITTING IN AND FOR THE COUNTY OF PROVIDENCE WITHIN THIRTY (30) DAYS OF THIS ORDER. SUCH APPEAL, IF TAKEN, MUST BE COMPLETED BY FILING A PETITION FOR REVIEW IN SUPERIOR COURT. THE FILING OF THE COMPLAINT DOES NOT ITSELF STAY ENFORCEMENT OF THIS ORDER. THE AGENCY MAY GRANT, OR THE REVIEWING COURT MAY ORDER, A STAY UPON THE APPROPRIATE TERMS.
