CONSENT AGREEMENT

The Department of Business Regulation ("Department") and Curreri Collision Center, Inc. ("Respondent") hereby agree that:

1. Respondent operates a Full Collision Repair License Auto Body Shop at 2160 Hartford Avenue, Johnston, RI 02919.
2. During the past three years, a series of complaints have been filed against Respondent. Two of the complaints were filed by consumers; five of the complaints were filed by an insurer; and one "submission" was filed by an insurer under Commercial Licensing Regulation 15.
3. The captioned filings allege violations by Respondent of R.I. Gen. Laws § 5-38-10 and Commercial Licensing Regulations 4 and 15.
4. The purported violations by Respondent include allegations of threats, harassment and intimidation; questionable repairs; refusal to return a repaired vehicle; denial of access to a vehicle; and significant dispute with a customer.

5. Respondent has recently settled the two consumer complaints, DBR numbers 09-L-0158 and 09-L-0167.


6. After several meetings with counsel for Respondent, the Department did determine that Respondent had engaged in certain questionable practices, in violation of R.I. Gen. Laws § 5-38-10 and Commercial Licensing Regulations 4 and 15.

7. Respondent now desires to resolve all matters pending before the Department.

8. By signing this Agreement, Respondent acknowledges and understands that the Department will take further administrative action, with notice and opportunity for hearing, upon a finding that it has engaged in any further violations of R.I. Gen. Laws § 5-38-1, *et seq.* and the related Commercial Licensing Regulations.

9. Respondent agrees to the payment of a \$5,000.00 administrative penalty, which includes the Department's costs in this matter. Respondent shall remit \$1,000.00 upon the execution of this Agreement, and four (4) payments of \$1,000.00 each by the first of the next succeeding four (4) months.

The Department of Business Regulation and Respondent Curreri Collision Center, Inc. hereby consent and agree to the foregoing.
