ORDER OF DISMISSAL

The above-entitled matter came before the undersigned as a result of an Order to Show Cause Why License Renewal Application Should not be Denied and License should not be Suspended or Revoked, Notice of Pre-Hearing Conference, and Appointment of Hearing Officer ("Order to Show Cause") dated December 5, 2017 and issued to Hymie Beaufort ("Respondent") by the Department of Business Regulation ("Department"). The Respondent held a license ("License") as a Certified Constable pursuant to R.I. Gen. Laws § 9-5-10.1 et seq. The Respondent's License expired on July 31, 2017. A pre-hearing conference was held on January 11, 2018. Subsequent to the pre-hearing conference, the parties spoke regarding possible settlement. The Respondent was to produce certain records which were not forthcoming. It was agreed by the attorneys for both parties that if the Respondent did not produce these records by December 31, 2018 that this matter would be dismissed. On January 4, 2019, the Department notified the undersigned that said records had not been produced. The Department represented that a dismissal of this matter maintains the status quo so that the Respondent is not licensed as a Certified Constable since his License expired and the Respondent is not barred from re-applying to be a Certified Constable but any such future application would be evaluated in light of the allegations contained in the Order to Show Cause.

Therefore, as a result of the foregoing and upon due consideration thereof, it is hereby ordered that the above-captioned matter is dismissed.
