*RI Residents <u>cannot</u> use reciprocity when applying for a license.

- Complete the online application on <u>www.nipr.com</u>
- □ A copy of the R.I. Background report from the Attorney General's office.
- □ A copy of the original passed R.I. exam results.
- □ \$250.00 license fee.

REQUIREMENT CHECKLIST FOR ALL NON-RESIDENT APPLICANTS HOLDING AN ACTIVE ADJUSTER LICENSE IN THEIR "DHS" (DESIGNATED HOME STATE):

- □ Complete the online application on <u>www.nipr.com</u>
- □ Hold an active license in your DHS.
- □ \$250.00 license fee.

REOUIREMENT CHECKLIST FOR ALL NON-RESIDENT APPLICANTS THAT DO NOT HOLD AN ACTIVE ADJUSTER LICENSE AND WANT TO DESINATE RI AS THEIR HOME STATE:

- □ Complete the online application on <u>www.nipr.com</u>
- □ A copy of the criminal background report. ** (All states except for MA & NY. See below)**
- A copy of the original passed R.I. exam results.
- □ \$250.00 license fee.

** Massachusetts and New York residents must follow the checklist box below in order to obtain a criminal background report. **

**<u>NEW YORK RESIDENTS:</u>

□ Complete the New York Fingerprint card process.

•**FEES:** \$250.00 License Fee.

•<u>ADJUSTER LICENSE CLASS:</u> You must choose one license class. Company, Independent, or Public Adjuster.

•<u>PROOF OF AN ACTIVE ADJUSTER LICENSE</u>: When applying online the RI Insurance Division will check the PDB (Producer Database) for the active DHS license. The applicant will only have to provide proof after they apply online if requested by the division.

• **CRIMINAL BACKGROUND REPORTS**:

• <u>**RI Residents:**</u> Criminal background report from the RI Attorney General's office. For questions relating to obtaining this report please call the Attorney General's office at 401-274-4400.

• <u>MASS Residents (Designating RI as their Home State Only)</u> Complete and attach the CORI request form which is located on the department's website.

• <u>NY Residents (Designating RI as their Home State Only)</u>: Follow the NY Fingerprinting Instructions to complete your background. This form is located under "Other Licensing Forms".

• <u>All Other Non-Residents (Designating RI as their Home State Only)</u>: Obtain a statewide criminal background report from the applicant's resident state. <u>OR</u> statewide criminal background report from an online vendor.

• <u>VETERAN INFORMATION</u>: The license fee is waived for any honorably discharged solider, sailor or marine who has at any time served the United States in time of war. <u>A copy of the</u> <u>DD-214 form is required for all veterans</u>.
