This letter serves to notify you that the Rhode Island Contractors' Registration and Licensing Board(CRLB) has determined that on or about May 26, 2022, at 17 East View Avenue, Cranston, RI 02920 violations of the following section(s) of Rhode Island General Laws were discovered and the CRLB intends to assess civil penalties as proposed.

Violation

5-65-3(m) - Failure to secure permits prior to commencing work

Violation Penalty

3,000

Description

On May 26, 2022, at approximately 11:15 am, respondent was observed at 17 East View Ave, Cranston, replacing Roof Sheathing and Prepping for Re-Shingling a single family house. This work is of the type which requires that a building permit be taken out prior to commencing work. Upon request, the respondent could not produce the required permit AND a check of the Cranston Permitting Database showed that no permit had been issued by Cranston prior to and/or during the Construction Project.

Violation

5-65-7(b) - Failure to have workers compensation insurance as required by R.I Gen. Law 28-29

Violation Penalty

Description

Workers observed performing roofing work. Upon inquiry, workers were determined to be employees of Respondent. Respondent is an employer subject to the Workers' Compensation Act and no exceptions apply.
