

Upon request, the respondent could not produce the required permit AND a check of the Warwick and East Greenwich Permitting databases showed that no permit had been issued by either.

Between May 3 and May 20, 2022, respondent performed Bathroom Remodeling and General Construction work at 63 Bay View Ave. Upon inspection, this work was deemed improper because:

The shelves in the Shower are barely hanging on, the tile in front of the tub was done improperly, as they have shifted and are not level to the rest of the floor, and none of the grout lines align.

The Water feed discharges rusty water for the inital 3 - 5 seconds then clears, indicative of a bad line, or valve in place at this time. The closet was moved to the hallway, the resulting walls are not plumb, and there is no access to the plumbing, as would be expected.

General sloppiness on the "finished" product, although there is still work to be finished.

NO PERMITS were pulled, and the work this project entailed would have required Permits for Building and Plumbing based upon what I saw on my review.
