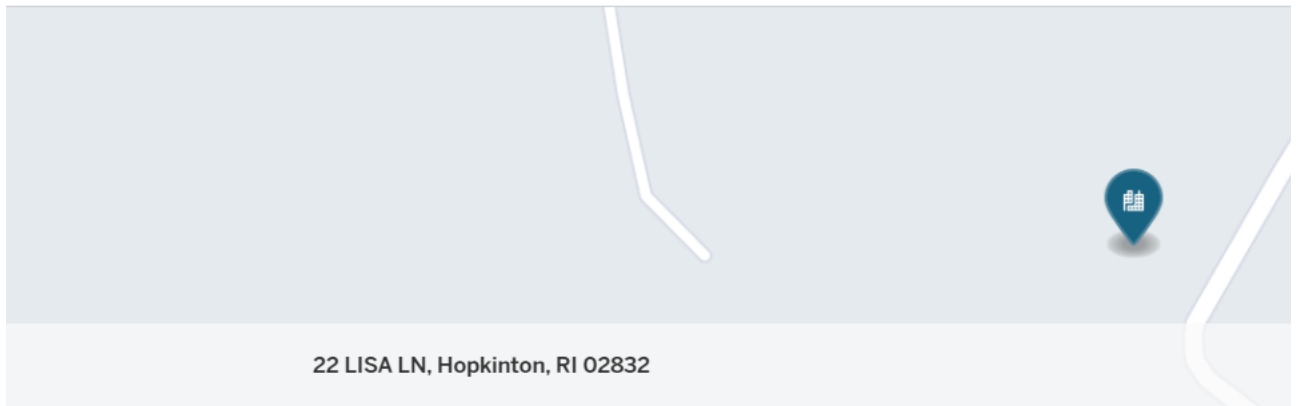

On or about February 2, 2021 , the respondent performed service's to restore the above mentioned property back to original pre loss conditions. L to include the following:

- CABINETRY**
- CLEANING**
- CONTENT MANIPULATION**
- GENERAL DEMOLITION**
- FLOOR COVERING - CERAMIC TILE**
- PERMITS AND FEES**
- FINISH CARPENTRY / TRIMWORK**
- FINISH HARDWARE**
- HEAT, VENT & AIR CONDITIONING**
- LIGHT FIXTURES**
- MIRRORS & SHOWER DOORS**
- INTERIOR LATH & PLASTER**

Upon inspection, this work was deemed improper because:

- No Permits were pulled for the above work which would require Permits from the Town of Hopkinton.
- No Bathroom fixtures (Towel Rack, Toilet Paper Rack, etc) were ever re-installed
- The vanity plumbing is leaking and has been since installation; The opening for said plumbing was rough cut and left open, visible to the eye from many angles
- The shower light fixture is missing
- The Shower Head was broken and left dangling off the piping
- The bathroom Painting is of very light coverage, shine thru of the old paint visible
- The tiling of the shower stall has been done I believe 3 times to date, with uneven grout lines visible on all three walls
- The new Barn style door, was never balanced or adjusted once installed, leaving it hard to pull and close, simple adjustment would prevent this
- The bathroom sink was damaged and left scratched
- The are many instances of lack of attention and resulting scratches, paint chipping, just disregard for the homeowners property

Fine amount: \$2,000

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
