3-65-3(l) - Advertising while not being registered

Violation Penalty

500

Description

On August 30, 2022, at approximately 10:00 am, while doing my Onsite Review at 76 Mendon Road North Smithfield, Warwick, I observed a Business Card advertising the services of Joshua @ Asphalt Tech. A check of the name/company showed that name/company was not registered with the CRLB.

I was also presented with Pictures and online advertisements for Asphalt Tech, provided by the Homeowner in Response to their looking into the Company as a result of the bad experience; I have presented as back up to my Violation.

Violation

5-65-3(o) - Failure to have written contract when work performed is in excess of \$1,000.00

Violation Penalty

500

Description

Respondent entered in an agreement to perform work at 76 Mendon Road North Smithfield on or about August 16, 2022. The agreed upon value of the work was ~\$800.00.

Upon request, Respondent stated that there was no written contract provided capturing the agreed upon amount.

After the disagreement and Involvement of third parties at the scene, a Bill was created and signed off on the transaction of the monies in the amount of \$2300.00 to protect the homeowner at her brothers direction.

Violation

5-65-10(a)(10) - Performed work, or arranged to perform work, without a valid registration.

Violation Penalty

1,000

Description

On or about August 16, 2022, at approximately 12:00 pm, the respondent put down an Asphalt Driveway repair at 76 Mendon Road North Smithfield,. This work is of the type which requires registration with the CRLB.

A check of the CRLB Registration database showed that the respondent was not registered with the CRLB at the time of the engagement and continues to be an Un-Registered Business with the CRLB.

Violation

5-65-22 - Failure to provide registration number on all advertising, contracts, and invoices.

Violation Penalty

250

Description

On August 16, 2022 the Respondent provided to customer a proposal/contract/invoice for the Repair services of a Driveway at 76 Mendon Road North Smithfield. This proposal/contract/invoice did not contain the respondents registration number, as they are an Un Registered Business with the CRLB.

Fine amount: \$2,250

Because you did not request a hearing within the time allowed, the Proposed Order has converted to a Final Order. The fines, as listed above, are now due and payable. If payment is not received within twenty (20) days, your case may be referred to the Office of the Attorney General for criminal prosecution pursuant to RIGL § 5-65-19.
