Respondent entered into a contract with Erik Dias on or about for November 11, 2021 to perform the following services:

"hired to install vinyl siding on my residence"

On or about July 11, 2022 the homeowner filed a complaint with the CRLB alleging, in pertinent part, that the Respondent had breached the contract. The investigation showed that the Respondent breached the contract as follows:

- I wrote a check in the amount of \$2500.00 on 11/11/2021 as a deposit for this work, which was agreed to in a written contract drawn up by hired general contractor.
- To date, no work was ever started on this project or sufficient materials produced to begin construction
- the project to install vinyl siding around the exterior of our residence and replace the front door was not started by this individual as of to date.

Fine amount: \$2,000

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
