
RE: FINAL ORDER AND SUSPENSION OF REGISTRATION

On or about August 12, 2022 , you were provided with a Notice of Violation/Proposed Order, a copy of which is attached and incorporated as if stated again in full, that the Rhode Island Contractors' Registration and Licensing Board determined that you were in violation of Rhode Island General Laws and intended to assess civil penalties.

Because you did not request a hearing or pay the fines as assessed within the time allowed, the Notice of Violation/Proposed Order has converted to a Final Order. The fines, as listed above, are now due and payable. If payment is not received within twenty (20) days, your registration will be suspended and your case may be referred to the Office of the Attorney General for criminal prosecution pursuant to RIGL § 5-65-19 and/or referred to the Central Collections Unit pursuant to RIGL § 42-142-8.

This letter serves to notify you that the Rhode Island Contractors' Registration and Licensing Board(CRLB) has determined that on or about July 27, 2022, at 237 Country Club Drive, Warwick, RI 02888 violations of the following section(s) of Rhode Island General Laws were discovered and the CRLB intends to assess civil penalties as proposed.

Description


On July 27, 2022, I observed ladders and painting materials indicating an active job site at 237 Country Club Dr., Warwick. Exterior painting is work of the type which requires a registration with the CRLB. Although no workers were on site, I spoke with the homeowner who indicated she had hired Carlos Carrillo of CARRILLO PAINTING SPECIALISTS, the respondent. A check of the registration database showed that the respondent had an invalid registration, which had expired on August 1, 2020. I made a phone call and spoke to Mr. Carlos Carrillo who confirmed that it was his job site as well as having placed a lawn sign with his company information. Mr. Carrillo informed me that he was unaware of the status of his registration.

Fine amount: \$500

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
