

#### Violation

5-65-10(a)(10) - Performed work, or arranged to perform work, without a valid registration.

#### **Violation Penalty**

500

#### Description

On July 14, 2022, at approximately 12:15 PM, I observed workers installing siding at 63 John St, Newport. This work is of the type which requires registration with the CRLB. Two of the workers informed me they worked for Vagne A Martins of MARTIN'S CONSTRUCTION, the respondent. A check of the registration database showed that MARTIN'S CONSTRUCTION had an invalid registration, which had expired on June 1, 2021.

#### Violation

5-65-7(b) - Failure to have workers compensation insurance as required by R.I Gen. Law 28-29

### **Violation Penalty**

500

### Description

Workers observed performing siding work. Upon inquiry, workers were determined to be employees of Respondent. Respondent is an employer subject to the Workers' Compensation Act and no exceptions apply. A check of the registration database showed that the Respondent did not maintain the required Workers Compensation Insurance.

Fine amount: \$1,000

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
