# Description

On July 14, 2022, at approximately 12:30 am, at 20 Spring St., Newport, I observed workers performing demolition on the front steps of the house. The front steps are considered a mean of egress and the construction or demolition is work of the type which requires that a building permit be secured prior to commencing work. A check of the permitting database showed that on July 14, 2022, no permit for this work had been issued by the City of Newport.

Fine amount: \$2,000

Because you did not request a hearing within the time allowed, the Proposed Order has converted to a Final Order. The fines, as listed above, are now due and payable. If payment is not received within twenty (20) days, your case may be referred to the Office of the Attorney General for criminal prosecution pursuant to RIGL § 5-65-19.
