On or about July 6, 2022 the homeowner filed a complaint with the CRLB alleging, in pertinent part, that the Respondent had breached the contract.

The investigation showed that the Respondent breached the contract as follows:

GC took approximately ~ \$30,200.00 for the Project, to include:

Demo work, the materials for remodel work, including windows sheetrock insulation etc The Contract also included Electrical and Plumbing work, which the GC is NOT LICENSED to perform; NO PERMITS were pulled for any of the described work, which would be Required by Providence to perform this type of work

The Demo work was started, leaving the apartment in disarray, and unusable

The GC took the funds and has not returned to perform any work since April 7, 2022

5-65-10(a)(14) - Failure to complete a project(s) for construction or willfully failed to comply with the terms of a contract or written warranty.

Description

On or about December 8, 2021 consumer and respondent entered into a written contract to perform a full remodel of a second floor apartment at 100 Sumter Street Providence RI. Said written contract required project to be started on or about January 10, 2022. On or about April 7, 2022 the Respondent ceased performing work prior to the completion of the project.
