On or about July 1, 2022 , you were provided with a Notice of Violation/Proposed Order, a copy of which is attached and incorporated as if stated again in full, that the Rhode Island Contractors' Registration and Licensing Board determined that you were in violation of Rhode Island General Laws and intended to assess civil penalties.

3,000

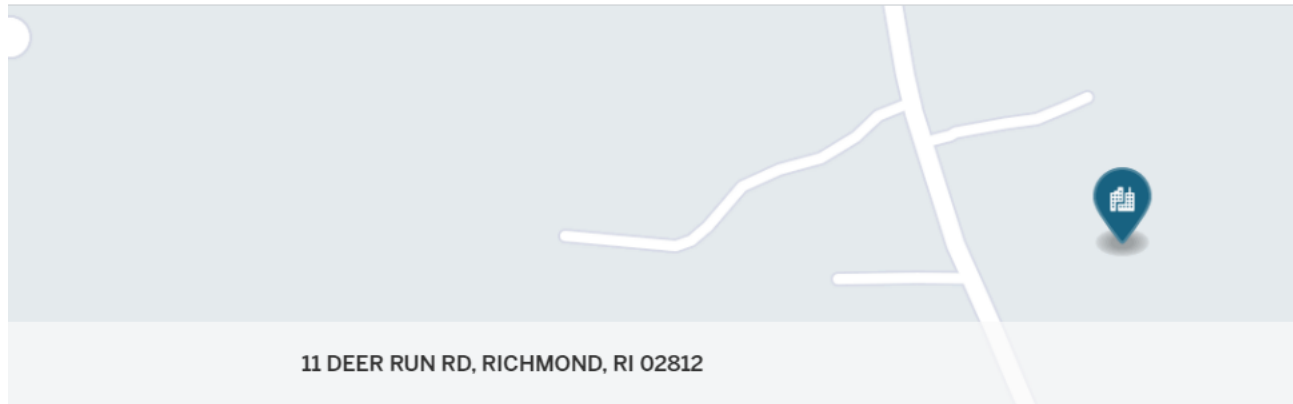
**Description**

On December 17, 2021, the respondent entered into a Contract to perform General Construction work at 11 Deer Run Road, Richmond RI. This work is of the type which requires that a building/electrical/plumbing/mechanical Permit(s) be taken out prior to commencing work. Upon request, the respondent could not produce the required permit and a check of the Richmond Permitting Database showed that no permit had been issued by Richmond.

**Violation Penalty**

2,500

**Description**

On April 4, 2022, the respondent began to perform General Contracting work/general construction, installing flooring including subflooring, plumbing work (not a Licensed Plumber) and various other construction. This work is of the type which requires registration with the CRLB.

Misrepresentation of Registration Status as VALID when the Registration was SUSPENDED, revoked, invalidated, inactive or unregistered as required by the Board.

5-65-10(a)(14) - Failure to complete a project(s) for construction or willfully failed to comply with the terms of a contract or written warranty.

**Violation Penalty**

1,000

**Description**

On or about December 17, 2021 the consumer and respondent entered into a written contract to Remove Existing Baseboard and Flooring on the First Floor of the Residence, Demo a Kitchen and the Flooring in the Kitchen, Install New Joists, sub-flooring and Renovation of the Kitchen, etc. Said written contract required the respondent to a Payment Schedule to reflect the Project progress. On or about May 19, 2022 the respondent failed to comply with the terms of the contract by breaking all communications with the Homeowners and failing to complete the Contracted work.

Fine amount: \$6,500

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
