CONSENT ORDER AND ORDER OF DISMISSAL

The above-entitled matter is currently pending before the Department on the Appellant's appeal of a prior Decision of the Appellee revoking its Class BV liquor license. Upon agreement of the parties, without the need for a hearing, and with the approval of the parties and the Department, it is hereby ORDERED:

1. That the Appellant effectuate a reinstatement of the Appellant's corporate charter with the Rhode Island Secretary of State, and provide the Appellee evidence of the same being completed by no later than April 2, 2023.
2. That subject to Paragraph 1 above, the above-referenced matter is hereby remanded to the Town of North Providence Town Council for the sole purpose of a hearing before said body with regard to a proposed transfer of said Class BV liquor license (the "Transfer") to a proposed purchaser of the Appellant.
3. Upon the Department's remand to the Town of North Providence Town Council as provided for in Paragraph 2 above, the Appellants' appeal is dismissed, with prejudice.






