This letter serves to notify you that the Rhode Island Contractors' Registration and Licensing Board(CRLB) has determined that on or about January 18, 2024, at 62 Whipple Road, Smithfield, RI 02917 violations of the following section(s) of Rhode Island General Laws were discovered and the CRLB intends to assess civil penalties as proposed.

Violation

5-65-3(j) - Hiring of non-registered subcontractor

Violation Penalty

500

Description

A check of the CRLB Registration database showed that Jay Tessier and Eric Romano are not registered with the CRLB. Upon further inquiry and admission by the respondent these workers had been hired to perform the work at 62 Whipple Rd, Smithfield by the respondent.

Violation

5-65-10(a)(12) - Contractor performed improper work

Violation Penalty

250

Description

During a 12/20/2023 CRLB field investigation improper work performed by the respondent was observed. This work includes ceiling and floor joist cut, projecting stud wall not flush with sill, windows are not fastened to the frame, and door frames of varying heights. The town inspector Michael DiOrio noted most of these and additional items in his

11/15/2023 failed inspection including ridge not supported on gable ends and 24 on center frame present versus the 16 on center frame in the contract.

Fine amount: \$750

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
