**TEMPORARY CEASE AND DESIST ORDER**

The above-entitled matter came for a hearing on July 31, 2024 pursuant to the Department of Business Regulation's ("Department") Order to Show Cause why Respondent Should not be Ordered to Immediately Cease and Desist; Notice of Hearing; and Appointment of Hearing Officer ("Notice") issued by the Department on July 16, 2024 to Michael Feole d/b/a Feole Landscaping and d/b/a JAGG Construction ("Respondent"). The Respondent's contractor registration is currently suspended, and the Department alleges violations of the contractor registration statute, R.I. Gen. Laws § 5-65-1 *et seq.*, by the Respondent. At the hearing, the Respondent agreed to the following:

1. A temporary cease and desist order is entered against the Respondent so that the Respondent shall not engage in any activity for which registration is required as a contractor pursuant to R.I. Gen. Laws § 5-65-1 *et seq.*
2. This order shall remain in effect until the resolution of this matter either by a decision after a full hearing or the parties resolve it without need for a hearing by consent order.

3. A full hearing in this matter is scheduled for **August 28, 2024 at 9:30 a.m.** at the Department of Business Regulation, Pastore Complex, 1511 Pontiac Avenue, Cranston, R.I.02920.<sup>1</sup>
