This letter serves to notify you that the Rhode Island Contractors' Registration and Licensing Board(CRLB) has determined that on or about February 20, 2024, at 118 Daboll Street, Providence, RI 02907 violations of the following section(s) of Rhode Island General Laws were discovered and the CRLB intends to assess civil penalties as proposed.

Violation

5-65-10(a)(10) - Performed work, or arranged to perform work, without a valid registration.

Violation Penalty

2,500

Description

Upon review of the complaint C-24-53 it was discovered that a flooring replacement project was underway at 118 Daboll St, Providence by the respondent. This is the type of work which requires registration with the CRLB. A check of the CRLB registration database showed that the respondent was not registered with the CRLB as their registration expired.

Fine amount: \$2,500

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
