



Pre-Packaged Hemp-Derived Consumables Packaging Requirements

All Hemp Derived CBD Products sold in a container and intended to be consumed or applied by a human or animal must be packaged and labeled in accordance with the Rhode Island Industrial Hemp Program Regulations: [230-RICR-80-10-1](#).

Consumable CBD Products are CBD Infused Edibles in solid and liquid form.

Includes: Gummies, lozenges, baked goods, capsules, tinctures, seltzers, juices, etc.

Packaging must be:

- Be opaque and light resistant
- Fully enclose the product
- Protect the product from contamination
- Be Child-Resistant (*packaged in accordance with the Poison Prevention Packaging Act of 1970 (15 U.S.C. §§ 1471 – 75) and 16 C.F.R. Part 1700 et seq.*)
- Not impart any toxic or deleterious substance to the hemp product
- Multi-serving packages must be **resealable** and have easily **measurable servings**.

Examples of acceptable packaging include, but are not limited to the following:

Pre-Packaged Hemp-Derived Consumables Package Labeling Requirements

Font Requirements for Required Information:

- No smaller than size 6 font
- In Times New Roman, Calibri, Arial, Helvetica or another font determined by the OCR to be easily readable.
- In black or white
- Clearly written in the English language. Licensees may also include accurate text in a foreign language **in addition** to the required English text.

Required Information on the Package Label:

1. The business(es) or tradename(s) and license number(s) of the licensee(s) who produced the product;
2. The business or tradename and license number of the licensee selling the product;
3. Unique identifier
4. Net weight of the product prior to its placement in the package (in ounces, grams, or volume as appropriate)
5. **Total THC and Total CBD in milligrams (mg);** (Must be in font larger than size 6, bolded, underlined and in red)
 - * **Per Single Serving (Cannot exceed 1mg THC)**
 - * **Per Package (Cannot exceed 5mg THC)**
 - **Hemp derived tinctures may contain up to 100mg Total THC
6. The serving size
7. The number of servings per package
8. If solvents were used in production, statement that discloses the type of extraction method, including any solvents, gases, or other chemicals or compounds used to produce or that are added to the extract
9. Any applicable instructions for use and safe storage; and
10. The required warning: "Warning: This product is not certified to be free of contaminants, is derived from industrial hemp, is not medical marijuana, and has not been analyzed or approved by the FDA."

Small Container Minimum Requirements:

If the immediate container holding the hemp-derived consumable product is too small to fit all the required label information, a licensee may put at a minimum the following information on a label that is securely affixed to the small container:

- THC/CBD content
- Tradename of the seller of the product and/or license number
- Unique Identifier
- Serving size and Servings per container
- "Warning: This product is not certified to be free of contaminants, is derived from industrial hemp, is not medical marijuana, and has not been analyzed or approved by the FDA."

Unacceptable Form of Label

Improper comic sans and other unacceptable font use, missing license number of producer and seller, missing serving specifications, missing THC content, missing ingredients, has medical claims.



Pre-Packaged Hemp-Derived Consumables

Package Labeling Prohibitions

Font Requirements for Required Information:

- No smaller than size 6 font.
- Permitted Font Types: Times New Roman, Calibri, Arial, Helvetica or another font determined by the OCR to be easily readable
- Must be clearly written in the English language. Licensees may also include accurate text in a foreign language in addition to the required English text.

Prohibited on the Package Label:

1. Any medical claims
2. Anything that reasonably appears to target individuals under the age of twenty-one (21), including but not limited to:
 - Use of animal characters,
 - Toys,
 - Cartoon characters or
 - Similar images.
3. Any false or misleading statements including false or misleading statements regarding health or physical benefits or as to the composition and profiles
4. Any seal, flag, crest, coat of arms, or other insignia that could reasonably mislead any reasonably prudent person to believe that the product has been endorsed, produced or manufactured by the State of Rhode Island or any agency thereof or municipality within
5. Images of children or minors
6. Words, designs or brands that resemble a product that is commonly associated with children or minors or marketed to children or minors
7. Symbols or celebrities that are commonly used to market products to minors
8. Words or any reference to “candy” or “candies.”



All required Information must be unobstructed and conspicuous.

Examples of prohibitions include, but are not limited to the following:



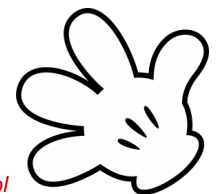
Animal characters, toys, cartoon characters, and images of children



Crest that looks like product is associated to state agency



Medical claims



Brand/ symbol used to market to minors
