This letter serves to notify you that the Rhode Island Contractors' Registration and Licensing Board(CRLB) has determined that on or about August 9, 2022, at [REDACTED] Cranston, RI 02920 violations of the following section(s) of Rhode Island General Laws were discovered and the CRLB intends to assess civil penalties as proposed.

Violation

5-65-3(a) - Bid to do work or arrange work without a valid registration

Violation Penalty

500

Description

On or about 8/17/21 the consumer and respondent entered into an agreement to remodel the basement laundry room space. This is the type of work which requires the contractor to be registered with the CRB. A check of the CRB database showed that the contractor was not registered with the CRLB.

Violation

5-65-3(m) - Failure to secure permits prior to commencing work

Violation Penalty

2,500

Description

On or about 8/17/22, the respondent started a project for construction at [REDACTED] Cranston RI. This work included, the relocation of the washer and associated piping, the electrical outlet, and wall studs and sheet rock. This is the type of work which requires that a Building, electrical and plumbing permit be taken out prior to commencing work. A check of the City database showed that no permit had been issued. Our records show this was the contractor's second offence.

Violation

5-65-10(a)(12) - Contractor performed improper work

Violation Penalty

500

Description

On or about 8/22/21, the respondent performed a bath/laundry room remodel that included the addition of walls (framing and blueboard), plumbing and electrical. Upon inspection, this work was deemed improper because there is a platform and several wall studs that are in contact with the concrete floor and not decay resistant.

Violation

5-65-18 - Failure to provide mechanic's lien notice

Violation Penalty

250

Description

Contracts for work require notice that the contractor provide the consumer with a notice that the contractor may file a lien in accordance with the Mechanic' Lien Law, as found in R.I. Gen. Law 34-28. As there was no written contract, for the property at 358 Princess Avenue, Cranston, the required notice was not provided to the consumer.

Violation

5-65-3(o) - Failure to have written contract when work performed is in excess of \$1,000.00

Violation Penalty

500

Description

On or about 8/17/21 the Respondent and claimant entered in an agreement for construction at [REDACTED] Cranston. The agreed upon value of the work was \$6,000.00. Upon request, no written contract was produced.

Fine amount: \$4,250

You have the right to a hearing. You must request a hearing in writing, to the Contractors' Registration Board, 560 Jefferson Blvd, Warwick, RI 02886 within twenty (20) days of the date of this mailing or

issuance of the Notice of Intent to Assess Civil Penalty. Failure to apply for, or to attend a scheduled hearing, will result in the issuance of a Final Order.
