This letter serves to notify you that the Rhode Island Contractors' Registration and Licensing Board (CRLB) has determined that on or about January 19, 2024, at [REDACTED] East Providence, RI 02915 violations of the following section(s) of Rhode Island General Laws were discovered and the CRLB intends to assess civil penalties as proposed.

**Description**

Between 12/4/2023 and 12/7/2023 a roof replacement project was underway, at [REDACTED] East Providence. This is the type of work that requires a registration with the CRLB. On 12/27/2023, 1/16/2024, and 1/18/2024 the CRLB sent a subcontractor list request to the respondent. As of 1/18/2024 the respondent has not provided a subcontractor list. According to the complainant the respondent hired four laborers to perform the work in four days. The respondent himself did not perform any work on the property. The respondent does not carry workers' compensation insurance according to CRLB records and DLT records.
