**ORDER OF DISMISSAL**

On or about June 29, 2015, the Providence Board of Licenses (“Board”) imposed a \$1,500 administrative penalty and a ten (10) day suspension on the Class B liquor license of Secreto, LLC (“Appellant”). Pursuant to R.I. Gen. Laws § 3-7-21, the Appellant appealed the Board’s decision on the administrative penalty to the Director of the Department of Business Regulation (“Department”). On or about July 2, 2015, the undersigned was appointed the hearing officer by the Director of the Department. On or about August 27, 2015, the Appellant withdrew its appeal. Therefore, based on the forgoing, the Appellant’s appeal is dismissed.


